They consist of a Female Academy, for which a fine brick building is to be erected this season; three private schools all, very well attended; and one public school, which numbers some two hundred pupils. In addition to these is the Western Baptist Theological Institute, with its extensive grounds, and its large, handsome and commanding buildings-the most conspicuous object in the town from this side of the river.

Covington contains seven Churches, viz 1 Presbyterian, 1 Methodist, 1 Baptist, 1 Episcopalian, 1 Christian, and 2 Catholic. It has a fine City Hall, the main room of which is of the dimensions of 54 by 60 feet. Some of its private residences are very elegand buildings, surrounded by beautiful and vell planted grounds. It has more graded and paved streets than any town of its size in the West. Its general health is excel-

The manufacturing industry of Covington is largely out of proportion to her other branches of business. She contains the following factories, viz:

1st. The Covington Cotton Factory. This runs 2,300 spindles, employs the year round about 80 persons, principally young women and boys and girls, and produces 300,000 lbs of Cotton Yarn per annum,
